Meeting was called to order at 9:00 a.m. by John Carr, roll call was taken. Those present included the following: John Carr, Mitch Bishop, Marcella Kunstek, Jerry Jackson, and Mark Danielson. Approval of Minutes:

Public Comments:

<u>John Smith</u> – If the installation is done after June 1st will the \$1,000 rebate still be given? Jennifer indicated that the timeline for the connections was going to be discussed at the meeting today and that the reimbursement timeline was 90 days after the connection. Discussion regarding extending the connection deadline for the property owners was discussed among the board members. Dan Byam further indicated that at this time the State has not officially approved the Reimbursement guidelines as it is part of the P.E.R. Amendment #3 – they did verbally approve it but not in writing.
